# **PREFACE**

Educare Institute of Dental Sciences (ECIDS), is first of its kind in the Malappuram district was established in the year 2006. First batch in 2007 with a intake of 50 students per year was started in 2007 with the approval of State government, DCI and is affiliated to Kerala University of Health Sciences, Trissur. . The institute was recognized by DCI in 2013 and the student intake was enhanced to 100 seats per year. .The campus with modern amenities overviewed by an illustrious faculty offers a perfect setting for an enriched academic experience and vibrant student life and also has state of the art facilities with latest equipments to cater to the needs of all patients and for students' training..The Institute has obtained approvals from all the regulatory bodies/viz: Dental Council of India and Kerala University of Health Sciences..

During the last 10 years of its existence, the Educare Institute has helped, in changing the entire profile of Chattiparamba, otherwise a sleepy village, and an unknown entity. As responsible members of the society, we have undertaken several measures, such as dental camps, health surveys and other works that helped the presence of the campus meaningful, for the improvement of the life of the people in the region.

The institute is located on the Kottakkal-Perinthalmanna State Highway. Frequent bus services are available throughout the day from all the nearby towns. Calicut International Airport is only 32 Km away and there are three railway stations Tirur, Kuttippuram & Angadippuram, all within 25 km radius.

# I. INTRODUCTION

- I. 1. This prospectus relates to admission to BDS Course in Educare Institute of Dental Sciences, Kiliyamannil Campus, Chattiparamba, Malappuram 676504, affiliated to Kerala University of Health Sciences (KUHS) for the Academic year 2018-19 to all seats including to NRI seats.
  - I. 2. The name, address, and the intake capacity of institution are given below:

I. 3. This prospectus contains the rules and regulations applicable for selection, admission, fees, etc to the BDS course for Academic Year 2018-19.

I.4 This prospectus is subject to modification / addition / deletion as may be deemed necessary by the College Management and also subject to further orders, if any, passed by appropriate authorities/courts of law.

# II, Eligibility for admission

No candidate shall be allowed to be admitted to the medical curriculum of first Bachelor of Dental Surgery (BDS) course until:

- a. He/ She has completed the age of 17 years on or before the 31st of December of the year commencing the prescribed academic session of the said course.
  - b. He/ She has passed qualifying examination as under:
- c. A candidate who has passed Higher Secondary examination of the Board of Higher Secondary Education, Kerala, or Examinations recognized equivalent there to by KUHS with 50% mark in Biology/Biotechnology separately and 50% marks in Physics, Chemistry and Biology/Biotechnology put together are eligible. The candidate must study English as a subject in the Higher Secondary course In respect of candidates belonging to Socially & Educationally Backward Classes the minimum marks required in qualifying examination in Physics, Chemistry and Biology/Biotechnology taken together and in Biology/Biotechnology separately is relaxed to 45% instead of 50% as above.

With respect to candidates belonging to Scheduled Castes and Schedules Tribes the minimum marks required in qualifying examination in Physics, Chemistry and Biology/Biotechnology taken together is relaxed to 40%. The eligibility criteria for admission to persons with disability of lower limbs (40 to 70%)— will be a minimum of 45% marks instead of 50% taken together in qualifying examination and competitive entrance examination for admission in BDS course or any other examination which, in scope and standard is found to be equivalent to the intermediate science examination of an Indian University/ Board, taking Physics, Chemistry and Biology/Biotechnology including practical test in each of these subjects and English.



# **INATIONALITY:**

Candidates must be Citizens of India / children or dependents of Non Resident Indians.Persons of Indian Origin (PIO)/ Overseas Citizen of India [OCI] will also be treated at par with Indian citizens for the limited purpose of admission. However JPIQ/OCI candidates will not be eligible for any kind of reservation.

#### **AGE**

Applicants shall complete the age of 17 years on or before 31stDecember 2017.

#### **ACADEMIC:**

As per the 'Dental Council of India BDS Course Regulation 2007', the applicant should have passed the qualifying examinations as under:

(a)The Higher Secondary Examination or the Indian School Certificate Examination which is equivalent to 10+2 Higher Secondary Examination after a period of 12 years study, the last two years of study comprising of Physics, Chemistry, Biology, and Mathematics or any other elective subjects with English at a level not less than the core course for English as prescribed by the National Council for Educational Research and Training after the introduction of the 10+2+3 years educational structure as recommended by the National Committee on education or a pass in plus two under the CBSE stream of syllabus.

Note: Where the course content is not as prescribed for 10+2 education structure of the National Committee, the candidates will have to undergo a period of one year preprofessional training before admission to the college.

Or

The Intermediate examination in science of an Indian University/Board or other recognized examining body with Physics, Chemistry and Biology which shall include a practical test in these subjects and also English as a compulsory subject.

Or

The pre-professional/pre-medical examination with Physics, Chemistry and Biology, after passing either the higher secondary school examination, or the pre-university or an equivalent examination. The pre- professional/premedical examination shall include a practical test in Physics, Chemistry & Biology and also English as a compulsory subject.

Or

The first year of the three years degree course of a recognized university, with Physics, Chemistry and Biology including a practical test in these subjects provided the examination is a "University Examination" and candidate has passed 10+2 with English at a level not less than a core course.

Or

B.Sc examination of an Indian University, provided that he/she has passed the B.Sc examination with mot less than two of the following subjects Physics, Chemistry, Biology (Botany, Zoology) and further that he/she has passed the earlier qualifying examination with the following subjects - Physics, Chemistry, Biology and English.

Or



Any other examination which, in scope and standard is found to be equivalent to the Intermediate Science Examination of an Indian University/Board, taking Physics, Chemistry and Biology including practical test in each of these subjects and English.

Note:

The pre-medical course may be conducted either at a Dental College or a Science College. Marks obtained in mathematics are not to be considered for admission to BDS course After the 10+2 course is introduced, the integrated courses should be abolished. Rounding off of the percentage of marks to the nearest whole number is not permitted. Candidates who have not passed their qualifying exam from the Kerala Higher Secondary Board, the CBSE or the ICSE shall provide an equivalency certificate obtained from KUHS.

# II. CRITERIA FOR ADMISSION & SELECTION PROCESS

Selection of Students will be only on the basis of inter-se-merit. They should be eligible for admission on the basis of National Eligibility cum Entrance Test(NEET -2018). For open merit candidate, they should have obtained the 50 % marks in the qualifying exam for the core subjects. Candidates belonging to SC/ST/SEBC will be considered for admission to this course only if they have scored a minimum of 40% marks in the National Entrance Examination. Candidates with Loco motor disability of lower limbs between 40% to 70% will be considered for admission to BDS course only if they have scored a minimum of 45% marks in the National Entrance Examination.

Relaxation of marks in qualifying examination: Candidates belonging to Socially and Educationally Backward Classes (as per G.O. (P) No. 208/66/Edn dated 2.5.1966 and amendments thereof), with total family a annual income not exceeding Rs. 6 lakhs, will have a relaxation of 5% marks in the qualifying examination. They need only 45% marks in the case of biology and 45% marks in the case of Biology, Physics and Chemistry put together. Candidates belonging to SC/ST categories need 40% marks in Physics, Chemistry and Biology put together in the qualifying examination. The SEBC candidates should submit their Community Certificate and Non creamy layer Certificate in the prescribed format (Annexure III) and their income certificate obtained from the concerned authority.

Selection to BDS course is made by the Controller of Entrance Examination, Kerala based on inter-se-merit from the Kerala NEET rank list including for the NRI seats. Selection will be done by CEE through a centralized counseling and allotment process. The vacancies if any after first allotment will be filled up by CEE through spot admission as per norms.

Candidates seeking NRI quota admission should produce copy of the following documents in the office of Commissioner of Entrance Examination along with proforma provided in the website of CEE, within the stipulated date.

- 1. Relationship certificate of the sponsored students to be issued by the revenue authorities as per GO (MS)No.243/2014/H&FWD dt. 06.08.2014
- 2. Overseas Employment Certificate issued by the Employer ,attested by the Embassy and if self employed, it should be attested by the Embassy
- 3. Passport with Visa stamped on it and attested by the Embassy.
- 4. The sponsor should be an Indian Citizen /overseas citizen of India /Person of Indian origin and the relevant document to prove the same.

# ADMISSION TO THE MINORITY QUOTA SEATS

The minority quota seats shall be filled up by the Commissioner for Entrance Examination from the candidates belonging to Muslim community based on inter-se merit.

Admission to the remaining 70 seats will also be filled by the CEE as per the state reservation norms.

Selected candidates shall take admission at the appointed time and date in the college/college counter with original documents after paying the tuition fee and other fee.

# IV HOW TO APPLY

The NEET eligible candidates who possess the qualifications prescribed in section II above alone are eligible to apply for BDS admission. The candidates who have secured a pass in the NEET examination have to upload their marks and ranks in respect of NEET examination in the CEE website online and the Commissioner of Entrance examination will publish the Kerala NEET rank list.

These candidates are given online facilities to exercise their option in the candidates' portal of CEE website.

#### **V.FEE STRUCTURE:**

Apart from the above each student will have to pay other fee Rs.81,500/-towards appropriate share of fees payable to the University/DCI, university Registration fee, Statutory fee, Government fees, Text Book, Lab fee, Uniform fee, Practical record books, Library fee, Student Kit, Sports and Cultural fee etc. In addition to this each student should also pay examination fee The candidates who fail in the university examinations are liable to pay lag fee as per Govt. norms.(Rs 10000/- per paper per attempt)

All students, including the SEBC, other economically backward students and the including the students admitted under minority quota will have to pay all fee specified in the in this prospectus.

Note:- SC and ST students are eligible to get tuition fee, hostel fee and pocket money from the Departments concerned

# VI.RESULT OF BDS EXAMINATION FOR THE LAST THREE YEARS

# VII.FACILITIES PROVIDED TO THE STUDENTS

HOSTELS: Hostel facilities are provided for Boys and Girls. Female students are provided with three well equipped hostel blocks surrounded by strong compound wall. The total intake of the girls' hostel is 300. Each room in the girls hostel is well furnished, equipped and bath attached. The service of two female Asst. wardens is available on full time basis.

The boys' hostel block is also well-furnished and well protected to accommodate 50 inmates.

**DEPARTMENTS:** All the nine Dental Departments as well as the Basic Science Departments are well furnished and well equipped as per the specifications prescribed by Dental Council of India and Kerala University of Health Sciences. The installation of CBCT facility in the Oral Medicine and Radiology Department is a remarkable mile stone in the developmental history of the Institution. Educare Institute of Dental Sciences is the only dental college to have this facility in the state.



**LIBRARY:-**The institution possess a very good library with modern books and journals both current and back volumes. The journals include 24 national and 25 international journals. The library hall is spacious enough to accommodate more than 200 students at a time with a reading room attached it. Online reference facility is provided to the students with 10 systems and the library is fully automated.

# TIE UP WITH GOVT.HOSPITAL MALAPPURAM

The institution has a tie up with the 116 bedded Govt. Hospital Malappuram that is within eight KMs from the college for the training of BDS students (GO (Rt) No.3046/2016 /H&FWD dt. 11-11-2016)

Spacious examination halls to accommodate 200 students, well-furnished canteen with 200 seating capacity and a large play-ground are the other attractions. The students are provided with locker facilities and girl students have rest rooms.

# TIE UP WITH MALAYSIA UNIVERSITY

Educare has expanded its horizon in the field of research and faculty exchange by establishing a tie up with University Saints Malaysia(USM). Through this collaboration the institute and the USM will endeavor to support and assist each other in the field of common interest by organizing workshops or conferences.

#### IX. CLOSURE OF ADMISSION AND REFUND OF FEES

IX. All the admissions will be closed on or before 31st Aug 2018.

IX. 3. If any student discontinues the studies for whatever reasons and without giving notice as stipulated at (8.2) above he/she will be liable to pay liquidated damages equivalent to the tuition fee for the entire duration of the course. In such cases, all certificates including the transfer and other certificates mentioned in the preceding paragraphs will be issued only after payment of all dues, including tuition fees for the entire course. No refund will be given for those students who discontinue their studies from the Institution after 25<sup>th</sup> Augest 2018.

# X. Discharge of students:-

Any student who does not clear the BDS Course in all the subjects within a period of 9 years including one year compulsory Rotatory period internship from the date of admission shall be discharged from the course.

  - d) Plus Two / 12th standard certificate
  - e) Mark list of qualifying examination (Plus Two]
  - f) Certificate of good conduct from the institution last attended
  - g) Transfer Certificate (T.C] from the institution last attended.
  - h) In cases where the candidates claim any sort of reservations/ privileges provided by the college, documents to prove such claims as described in Annexure II
  - i) Certificate in proof in original of SEBC status (Non creamy layer and Community Certificates] and latest Income Certificate obtained from the Tahsildar / Village Officer / Authority concerned
  - j) Community Certificate in original from the concerned Tahsildar/Concerned authority in the case of SC/ST candidates.
  - k) Equivalency/Recognition certificate of the qualifying examination, if applicable.
  - 1) Migration Certificate, if applicable
  - m) Anti-ragging Undertaking
  - n) Medical fitness certificate
- XI. 2. TWO set photocopies of all the documents / certificates listed above (9.1) attested by



the gazette officer / head of the institution where the student had studied also has to be submitted at the time of admission.

XI. 3. Ten passport size photographs of the candidate (one of them shall be laminated on the facing side)

# XII. REDRESSAL OF GRIEVANCES

Any grievances/ complaints regarding selection and admission can be brought to the notice of the Coordinator of Admissions as well as to the Director / Manager of the college concerned, within 24 hours of occurrence of the grievance.

Student Support and Guidance cell has been constituted in the College as per the direction of the Kerala University of Health Sciences.

# XIII. CODE OF CONDUCT

Every student is required to adhere strictly to the code of conduct and dress code of the institution.

#### XIV. PROHIBITION OF RAGGING

- 1. Ragging / any type of misconduct towards any student either in the college campus or outside will be considered as criminal offence and will be immediately reported to the police. Perpetrators will not be permitted to continue their studies.
- 2. Every student shall at the time of admission furnish a character certificate from the institute wherefrom they have passed the qualifying examination, which would mention the status of their behavioral pattern especially in terms as to whether they have displayed persistent violent, or aggressive behavior or any desire to harm others.
- 3. Students and parents shall, at the time of admission, furnish an affidavit to the Principal and submit the same to the MHRD online to the effect that the students shall not indulge in ragging.
- 4. Anti-ragging Committee and Ant-Ragging squad are functional in the college.
- 5. Use of mobile phones in the Educational Institution is banned by the Government.
